- Current proposal for Nursing in Malone is under review by NY State Department of Education.
- New Director has toured the SUNY Potsdam grounds for future planning for the Path to Potsdam program.
- Monday, May 14 will focus on Assessment student learning outcomes.

Dean of Admissions Report

Chris Tacea highlighted his report:

- Fall 2018 applications have grown exponentially showing a spike in numbers when compared to
 the last three years. This spike is predominately in relation to the Path to Potsdam applications.
 Numbers without the Path to Potsdam program shows that our numbers are still trending
 upward in the same comparison. There are weekly progress reports which show how these
 numbers convert from applications to deposits to students in the seats.
- First Accepted Student day in Manhattan occurred on May 4, 2018. The students received email credentials; 48 students were packaged for the program with 42 deposits. June 22/23 placement

testing will be held on June 22nd and 23rd. There is potential to have a similar event in July. The enrollment cap still holds at 60 students to start Fall 2018.

- Financial Aid processing is no longer in CAMS, working solely in PowerFaids allowing the department to work more efficiently.
- Recently Pell had been announced as a year round option for students.

Vice President for Administration/CFO:

Bob Farmer highlighted the proposed contract between NCCC and JMZ Architects and Planners. This spring Bob and Lisa led a committee who met to re-explore the needs of the College when compared to the existing 2010 Campus Master Plan for Saranac Lake. The committee consisted of stakeholders from the Saranac Lake campus. The board discussed the contract and the potential financial implications of the College.

- Bob Farmer and Bruce Rowe will present the 5 year financial plan at the May 14, 2018 College Senate meeting.
- A few members of the College attended a meeting on May 9, 2018 to discuss the proposed School of Applied Technology. The faculty voiced they prefer a consultant be hired, and not a faculty member, to do a feasibility study. Steve Reed and Steve Tyrell understood the concerns and agreed that this is a better way to ensure an objective report. The faculty will be invited to sit in with the selection process. The board discussed the faculty perspective of hiring a faculty member verses a consultant and majority concurred with the potential conflict of interest. It is in the best interest of the College to have guidance on the report which would show the "right thing to do" for the College, with data to support it. The Foundation approved on Wednesday to underwrite up to \$100,000 for this vetting process.
- Members of NCCCAP shared questions with Steve Reed and Steve Tyrell. They are working to address these questions and answers will be available in the near future.

North Country Community College VPAA Report to the Board of Trustees June 28th, 2018

Greetings to you all. I hope you are all enjoying the start of the summer. Please find updates from our area here:

* Academic Planning, Programs and Policies:

- Academic Planning
- Several of us met with representatives from Adirondack Health, the University of Vermont's Continuing Education Department and community members to explore health care career path opportunities and barriers late May. It was a good discussion and we are awaiting a summary report on the meeting.
- We are wrapping up our work with IP and others on a project they are referring to as *School to Work*, to respond to a significant number of vacancies at the mill, both currently and projected into the future. One proposal is for the College to assist with some preemployment training with the goal of improving chances of prospective employees to be hired. This training addresses many of the items we heard at our campus advisory boards regarding the lack of workforce readiness across our communities.
- Our Academic Planning team will be hosting workforce and economic development representatives from Essex and Franklin County on Tuesday, June 26th from 10:00am-1:00 pm. The objective for the meeting is to hear from experts in the area of work-force regarding needs, trends and challenges to help us better plan our academic programming.

• Academic Programs:

- o Advanced EMT: Approved by SUNY on June 15th, 2018 and has been sent to NYSED for review.
- o AS Business: Sports Management: Approved by SUNY on June 18th, 2018 and has been sent to NYSED for review.
- o AAS Nursing: Approved by SUNY in Spring 18; pending review by NYSED and Office for the Professions.
- o AAS Entrepreneurship Mgmt Malone: Pending submission to SUNY.
- o AA Lib Arts and Sciences Hum/Soc Science English advising track. Pending submission to SUNY.
- o AA Liberal Arts Childhood/Early Childhood Teacher Ed Transfer: A group of us made changes to the proposal to align it better with SUNY Potsdam and SUNY Plattsburgh's programs and sent it along to them for review. When our faculty return in August, we will pick it up again.
- o Certificate in Entrepreneurship No update to report.
- o AAS Human Services Ticonderoga: No update to report.
- *SUNY Potsdam Proposal:* No update to report.

- Assessment of Student Learning: Our report on our work towards developing a mature and systematic process of assessment is being compiled for our follow-up Middle States report due at the end of summer. The faculty, under Sarah Maroun's leadership, made significant strides in addressing the issues raised by Middle States in a sustainable and meaningful way.
- *College Bridge:* No update to report.
- Academic Policies: Academic Integrity Policy and Classroom Conduct Policy The changes made by our counsel was approved by the Academic Policy and Standards Committee and the College Senate at their last meeting of the year.

***** Campus Advisory Boards:

o Our spring meeting in Ti was scheduled for Friday, May 4th, 2018 from 9:00-11:00 am. We'll share with you updates at the meeting.

***** Faculty/Staff Appointments:

There are several appointments before the Board today, many temporary full-time appointments for the 18-19 year. We will also be recommending that Sarah Maroun be appointed as our Associate Dean of Academic Affairs.

***** Grants and Experiments:

Here is a brief update on our grants:

- o Second Chance: Summer 19 courses are underway and our 18-19 budget request has been submitted.
- O P-TECH Programs We recently learned that one of our P-TECH programs, PACE, which was located at Edwards-Knox Central School has decided to cease operating at the end of this 17-18 academic year. Their decision was largely based on uncertain funding from participating school districts coupled with a series of leadership changes at the program. This leaves us with a single program, Northern Borders P-TECH, located at FEH BOCES.
- o Perkins: Our 18-19 application will be sent out the NYSED by June 22nd, 2018.

He took Modern Algebra 1 (group theory) and Linear Algebra 2 from me in two different years, so I have had the opportunity to observe his performance as a student in classes that are typically quite difficult, and I have had the opportunity to observe him socially with his peers. 2) <u>Strategic Plan – Periodic Updates</u> – Stacie Hurwitch shared with the College community an updated progress report regarding the work completed in the 2017-20 strategic plan.

- 3) Path to Potsdam Update College presidents from SUNY Canton, SUNY Potsdam and NCCC continue to discuss the Path to Potsdam program, and discussions include items that should be weighed for consideration in the development of a future service area agreement.
