

## Important Deadlines and Dates

To be considered for federal student aid for the 2022-2023 award year, you will need to complete the Free Application for Federal Student Aid (FAFSA) online at [www.fafsa.gov](http://www.fafsa.gov) between October 1, 2021 - June 30, 2023. Any corrections or updates must be submitted by September 12, 2023.

### Deadline to submit required documentation

2022-2023 Academic Year – Regulation is 120 days after the last day of the student's enrollment, whichever is earlier. No refunds or book deferments will be processed.

#### **Fall 2022 E Grades Due**

September 7, 2022 - 1<sup>st</sup> Quarter Courses  
September 16, 2022 - Full Semester Courses

#### **Spring 2020 E Grades Due**

February 8, 2023 - 1<sup>st</sup> Quarter Courses  
February 17, 2023 - Full Semester Courses

#### **Add/Drop Period**

If a student drops a course before or during this period, there is no record on the transcript and your financial aid may change.

#### **Fall 2022 Add/Drop Dates**

August 29, 2022 – September 2, 2022  
Full semester Courses & 1st Quarter Courses

October 24, 2022 – October 28, 2022  
2nd Quarter Courses

#### **Spring 2022 Add/Drop Dates**

January 30, 2023 – February 3, 2023  
Full semester Courses & 3rd Quarter Courses

March 22, 2023 – April 4, 2023  
2nd Quarter Courses

#### **Official Withdrawal Period Full-semester courses**

If a student officially withdraws from a course(s), he/she will receive a “W” grade on his/her transcript. The “W” will not affect his/her GPA but will impact the student’s SAP. No withdrawals for full semester courses will be accepted after November 18, 2022 for fall 2022 and April 21, 2023 for spring 2023 without the signature of the Vice President of Academic Affairs

**Withdrawal Period Dates**
