After completing option A or B, you will receive the Verification of Non-Filing Letter from the IRS in the mail. You cannot request a non-filing letter by calling the IRS. (Should you have difficulty obtaining this letter please see the reverse side of this form.)

After you receive your Verification of Non-Filing Letter from the IRS:

- 2) Check to make sure the document you received is correct. (Federal aid regulations prohibits us from accepting an IRS RAIVS (13873-V) document.)
- 3) Keep a copy for your own records.
- 4) Write the student's name and NCCC ID # on the top of IRS letter. (Please note: There is no identifiable information on this form. Unless you write your name and ID# at the top we will not know who it belongs to.)
- 5) Submit the Verification of Non-Filing Letter to the Financial Aid Office.
